

COUNCIL ACTIONS

The Council met on Wednesday, September 10, 2008 at the Chevy Chase United Methodist Church. All Council members were present. The meeting began at 7:55 p.m.

Prior to the beginning of the regular agenda, **John and Phil Eckert** brought to the Council's attention their concerns regarding insurance coverage if an inflated ride should be placed on their lawn for the Party in the Park. They expressed concern because one of the large trees on their property, which is scheduled to be removed, might pose a hazard to children at the party. The Village Manager agreed to look into the type and level of insurance coverage the town had regarding this situation and also agreed to explore a "plan b" wherein the yard would not be used at all. She agreed to contact the Eckert family and let them know her findings.

PUBLIC SAFETY ISSUES

The Council discussed the thefts of items from individual cars. (see story this issue.)

BUILDINGS AND ROADS

Councilperson for Buildings and Roads announced that **Nathan Billig and Gail Weinmann** received a permit to resurface their existing driveway and to build out the steps leading to it.

The **Heynen/Arconti** family has expressed an interest in renovating their garage. Because they have one of a number of "through-lots" (determined by the County to have two front yards), Carolyn Greis advised them to first consult with the County regarding just what they would be permitted to do.

The **Scheck** family has applied for a variance for a retaining wall and patio in the rear setback. The Council will vote on it at the October meeting.

The **Michaels** family of Spring Street has received a permit for a rear patio.

IN THE EVENT OF A POWER FAILURE:

CALL PEPCO's emergency line (877) 737-2662. The more people who call, the higher up on the action list we get—so don't count on your neighbor to call, do it yourself, early and often if it hasn't been repaired by the time they predict. Our most recent power outage was the result of a downed tree; hopefully we'll not suffer more of these outages, but if we do, don't hesitate to call.

The Village Manager and the head of Buildings and Roads discussed some of the problems that have occurred with the demolition and subsequent beginning of construction at 6803 Florida Street. They are working with developer Jim O'Brien to improve the quality of compliance with Section 3 requirements regarding traffic patterns, parking, etc.

The Village Manager and the head of Buildings and Roads are working with Verizon to define the terms of their utilities permit so that they can begin phase one of their work to install FIOS in Section 3.

The bulk of Section 3's lights are all mercury vapor lights. As of 2010, it will be illegal to use those lights, so the Council is beginning the process of exploring alternate lighting schemes. Because the state has passed legislation allowing municipalities and counties to purchase and maintain their own lights, the Council is beginning the process to see if we can't get a more attractive, energy efficient light that would release us from excessive PEPCO "maintenance" charges. There is hope that at least on the Connecticut Avenue and Brookville Road corridors, that we could select a light fixture that would be compatible in terms of design with fixtures planned by Chevy Chase Village, Martins Additions, Section 5 and the County, all of whom have lighting on those two corridors.

FINANCIAL REPORT

The Council plans to search for better interest rates in new FDIC financial institutions to lower the amount held in our collateralized account.


The Council discussed the objections made by the new CCUMC financial person regarding our estimates that the Church and school produce the equivalent of 8 households' worth of trash each year. The Village Manager agreed to have the current contractor monitor that production and the Council agreed that going forward we could make an adjustment but that we would not revise the number downward for previous bills incurred. After consultation with the trash company, it was felt that current production is closer to six households, but that with the pastor's household not paying taxes, that the number was seven now instead of eight. The financial person will be informed by the Village Manager.

COMMUNITY AND SOCIAL

The Village Manager reviewed plans for the Party-in-the-Park and made adjustments to the beverage order based on suggestions from the Council. It was also thought that it would be a good idea to have a policeperson present at the event.

Planning for the Halloween party is well underway for this year and will again be held at the Park with a parade up Shepherd St. to the Church for a pizza dinner.

The meeting adjourned at 9:00 p.m.



NEIGHBORHOOD NEWS

It is with great sadness that we report the passing of a long-time neighbor, **Garth McCormick** of Raymond Street. A retired mathematics professor at George Washington University, Dr. McCormick co-wrote an influential book in his field of mathematical optimization. Along with Anthony Fiacco, he wrote *Nonlinear Programming: Sequential Unconstrained Minimization Techniques*. The book received the 1968 Frederick W. Lanchester Prize in operations research and was reissued in 1990 as part of a series of books called Classics in Applied Mathematics. The book opened up many research opportunities in applied mathematics. Techniques derived from its findings have been used in such diverse fields as microwave antenna design, electric power generation, telescope design and airline crew scheduling.

Dr. McCormick came to the Washington area in 1960 as a mathematician with the old Operations Research Office of Johns Hopkins University. The group later became the Research Analysis Corp. in McLean.

He joined the faculty at George Washington University in 1971 and wrote several other books on nonlinear programming. He taught at GWU until he was disabled by a major stroke in 1992. Before his stroke, he enjoyed running and tennis. He was a member of the Cosmos Club for more than 30 years.



McCormick** of Chevy Chase; four children, **Jessica McCormick** of Chevy Chase, **Rachel McCormick** of Falls Church, **Caroline Razzaq** of Gaithersburg and **John McCormick** of Bethesda; and three grandchildren. In lieu of flowers, contributions may be made to the Juvenile Diabetes Research Foundation or the National Institute of Neurological Disorders and Stroke.

CAR THEFTS AGAIN IN SECTION 3!

Nine Section 3 resident cars were entered and goods and money taken in early September. A crime alert was sent out via e-mail and subsequent to that notice, a number of other residents alerted the Village Manager that their unlocked cars had been "tossed" for spare change and whatever else of value could be found. Four Georgia Street residents' cars were opened and in addition to spare change, a laptop and a GPS device was taken. Two cars on Spring Street were opened and "tossed" and two cars on Taylor Street were also opened and goods and change taken.



The County police have arrested an individual doing the same kind of thefts in the Germantown area but as yet have not found any link to downcounty thefts which continue to grow at an alarming rate. Once again, as safe and wonderful as this neighborhood is, we urge everyone to remove all valuable items and **LOCK YOUR CARS** every night. As best we can determine, all or most of the cars broken into on this last round of thefts were unlocked.

GO SLOW NEAR CHEVY CHASE ELEMENTARY SCHOOL

The Town of Chevy Chase has adopted new traffic patterns and a new 15 mile per hour speed zone around the elementary school. One way provisions have been created for Rosemary Street and Hillcrest Place, crosswalks near the school have been improved and the drop-off zone on the east side of Hillcrest Place next to the school has been extended. School buses leaving the school now exit by going west on Rosemary, south on Maple Avenue to make it safer for children.

The new SLOW ZONE goes from the school west to about halfway between the school traffic circle and Maple Avenue, north to Sycamore Street, east to the intersection of Meadow Lane and Woodside Place and south of the circle along Hillcrest Place near its intersection with Bradley Lane.

Parents of the school may have already been made aware of these changes, but those without children in the school should be advised of these changes.

COUNCIL ACTIONS

July minutes were inadvertently not printed in the September newsletter and appear here for the record.

The Council met on Wednesday, July 9th. Jon Newhard and Donna Harmon were not present.

PUBLIC SAFETY ISSUES

A number of homeowners had cars broken into on Spring and Taylor Streets and goods taken from their cars. An e-mail alert was sent out to the community regarding the need to lock car doors. Both County and Chevy Chase police were also alerted.

BUILDINGS AND ROADS

Betsy Babbington of Florida Street has applied for and received a permit for a rear deck and balcony. The Edelen family has applied for and received a permit for a fence within their property line. The Manning family received a permit for fencing for their property.

The Meisel family received a variance to place a shed within the side setback on their property. The Greis/Nott family received an extension of their variance to bump out the rear of their property into the setback.

The Council discussed painting the curb at Taylor Street and Connecticut Avenue so that people would not park on the south side of the street close to the intersection.

The Council expressed concern about both the telephone pole that has been hit several times at the corner of Taylor and Brookville Road. (Verizon has been notified for months) and the two dead trees which have the potential to come down onto the roadway opposite that damaged pole. The owner of the dead trees is aware of her liability but has yet to take action to remove the trees from the property.

The Village manager is exploring manufacturers and pricing for replacement signs for Section 3 stop and no parking signs.

FINANCIAL REPORT

The Village Manager reports that as yet WSSC had not reimbursed us for the repairs following the installation of new water lines at Fulton and Taylor Streets. She is working with a person at the Commission to try and remove some unnecessary legal language in an agreement with them. The basic funding, however, has been approved by WSSC for reimbursement.

The Council raised the amount of health insurance paid for the Village Manager.

COMMUNITY AND SOCIAL

The New Neighbor's Barbeque is scheduled for July 17th, and a tent has been obtained so that the event can go on rain or shine. Rocklands Barbeque is all set, as is the Ice Cream man!

New Neighbors have all been invited. We expect a good turnout.

The trucks for A Wider Circle will be in the community on Friday, July 18th and Saturday July 19th for items for less fortunate families. Contacts have been made with all those who are making large donations to schedule the truck pick-ups on the 18th. The truck will sit at the Gazebo park for 4 hours on the 19th for items that can be brought to it.

The Party-in-the-Park dates are September 14, with a rain date of September 21st. We agreed to have more kid's food because the adults seem to like it too, and chocolate milk for the children.

The meeting adjourned at 8:45 p.m.


adult witches and designers to transform and decorate the hall and help serve the food. Please contact Donna Harmon and Natasha Saifee to volunteer.
