WIND STORM MAKES ITS MARK ON GEORGIA STREET



On March 1, amazing winds whipped around Section 3, causing one of our stately Silver Maples to topple into a neighbor's house and yard. The tree in front of the Daw home came down with a thud in front of the Steuart-Kret home, glancing damaging blows on the roof, damaging a window and some siding and scratching a car while it took out the electricity to both homes. Miraculously, no one was hurt and the Steuart-Kret's much loved crape myrtle survived unscathed.

The Daws were able to get tree people in quickly to remove the incredible hulk, but sadly it took longer to restore electricity to the Steuart-Kret's home and will take longer to restore the house.

Each year before hurricane season, the Village Manager tours the neighborhood with Paul Wolfe, our town arborist. We look for trees that might need attention, both in the public right-of-way and on private property. Many of you have received letters from the Village Manager calling your attention to vulnerable trees. It's not always possible to see if a tree is diseased, but it is safe to say that if you have an Ash tree, you should be certain to have it checked for the Emerald Ash borer which has decimated the Ash tree population in our area and has damaged Silver Maple, like the fallen Georgia Street tree, it's important to know that they don't do well over time. Their useful life is about 25 years, after which time, it's good to keep an eye on their health. If you are uncertain, you can always consult an arborist who can examine the tree and, if necessary, test the strength of the bark by drilling into it.

**In accordance with the Americans with Disabilities Act and our desire to have our meetings open to everyone in our community, Council meetings are held at the Chevy Chase United Methodist Church which has handicapped elevator access via the parking lot entrance. We are grateful to the Church for their generosity in allowing us to use their facility each month.*



COUNCIL ACTIONS

The Council met on Wednesday, March 8 at CCUMC. All Council members except Council Chair Bill Brownlee were in attendance. The meeting came to order around 7:55 p.m.

The Council voted to approve the minutes of the February meeting as published in the March newsletter.

PUBLIC SAFETY

Police continue to patrol our streets, no incidents to report. A number of citations have been issued for drivers going through the stop sign at Brookville Road and Taylor Street.

BUILDINGS & ROADS

Albemarle LLC, owners of 3617 Taylor Street, was granted a variance to retain the northern and eastern walls of the existing three-car garage but to significantly reduce the size of the garage to fit some storage and a single car garage and driveway.

The Village Manager reported that the Planning Board Staff has not released its revised recommendations on short term rentals as yet but they had received the letter from the Council expressing grave reservations regarding blanket use of short term rentals.

VOTER REGISTRATION

Unlike most jurisdictions, if you live in Section 3, we want you to vote in our elections—even if you're not a U.S. citizen. Our only requirement is that you be 18 years of age and own or rent in Section 3. Those who have registered with us in prior years do not have to re-register. If you are listed in the Section 3 directory, you don't need to show us proof that you're a resident. If you're not listed in the directory, we will need a copy of a driver's license with your Section 3 address or a bill proving that you are indeed a resident.

Just fill out this form and submit it to the Village Manager (3801 Bradley Lane) prior to 5:00 p.m. on election day and we'll be happy to have you vote.

The Maryland Municipal League is working with the State Highway Administration to achieve better communication with municipalities regarding their work program. It appears that no legislation will be introduced in hopes that this can be achieved without a legislative mandate.

The "Block the Box" legislation has managed to garner support in the legislature, but it's not yet certain if it will pass. We continue to monitor this legislation.

The Council voted to approve the clarification of the ordinances regarding setbacks. It will now be sent to the County Council which has 30 days to review it. If they have no objections after the 30 days, the new wording will become the prevailing ordinance in Section 3.

Our attorney recently discovered that we had no franchise agreement with Washington Gas. This legal formality is necessary for them to upgrade and service our homes. The Council approved an agreement which would codify what has already been the practice by Washington Gas.

The tenants at 6700 Brookville Road have not put out the sign offering tarot card readings, etc. No complaints have been received as a result.

FINANCIAL REPORT

The Council discussed the proposed FY 17-18 budget and approved the rough outlines for publication in the newsletter (See story this issue).

COMMUNITY & SOCIAL

The Council agreed as to who would cover the adult beverage bar at the Everybody's Irish Party. The Village Manager reported that she may opt to have a tent warmer if it's too cold. All the food has been ordered.

Food Truck Night participants have all confirmed their participation on May 7. We have invited both Martins Additions and Section 5 residents for the event.

The Village Manager and the Council discussed the Annual Meeting on May 9 and will try and get a speaker on the Bethesda Master Plan.

The Council agreed that the House Tour should be May 21 this year because we have the Annual Meeting and Food Truck Night earlier in the month and we don't want to interfere with Mother's Day.

The Welcome New Neighbors' event will be July 13. The Party in the Park September 17 with a rain date of September 24.

The meeting adjourned at 9:15 p.m.

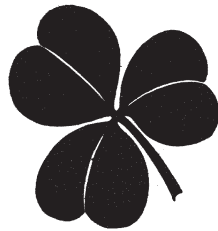
SAFETY SURVEY FOR SENIORS

BUDGET PRIORITIES SET FOR FY 17-18

The Council set four key priorities for the upcoming year:

1. To mill and pave Spring Street from Delaware Street down to Georgia Street and remove and replace all older driveway aprons with wider wing aprons to allow for greater ease in turning into the street. This job will include repairing any deteriorated foundation beneath the top asphalt layer.
2. To mill and pave Georgia Street from Bradley Lane to Raymond Street and remove and replace all older driveway aprons with wider wing aprons to allow for greater ease in turning into the street. This job will include repairing any deteriorated foundation beneath the top asphalt layer.
3. To revisit with Pepco the idea of purchasing and installing new induction lighting to provide safer more even lighting throughout the community.
4. To continue to support community-wide social activities that bring us together as a neighborhood and to build links between neighbors.

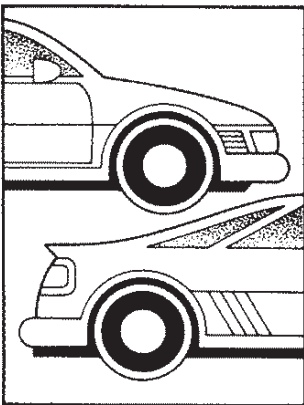
The budget (see next page) reflects these key priorities. If we manage to negotiate the purchase and installation of new street lights with Pepco, then the cost of those improvements will come out of our Capital Improvement Fund, not out of the operating expenses for the regular street lighting bill. As with all renovations, we have budgeted a certain amount to repave our streets, however, if when we mill down the surfaces defined above and we find we need to make major repairs of the foundation of the roadbed, any excess expenses would also come out of the Capital Improvement Fund. We have allocated a certain amount anticipating that some patching will be required, but we are uncertain as to the makeup of the road base on Georgia Street. Last year, we had core samples pulled and those on Delaware Street prompted us to think that the entire roadway was asphalt on top of gravel alone...along with no foundation. It turned out that the sample taken on Delaware Street was of old, rotten concrete, which appeared like gravel. Once we opened the street, we had to replace only a third of the base, NOT the entire roadbed. What this taught us was that even with core samples, we can't always know what's beneath to top coat of asphalt.

Understanding this, we have estimated the cost of modest repairs but if we have to do more, we can fall back on our Capital Improvement Funds to make up the difference. Just as with an old house, when you open a wall, you never know what you're going to find inside...

All other costs are largely similar with only a few modest increases. If residents have any questions regarding the budget, we urge you to contact the Treasurer, any of the other Council members or the Village Manager to get those questions answered in advance of the Annual Meeting.

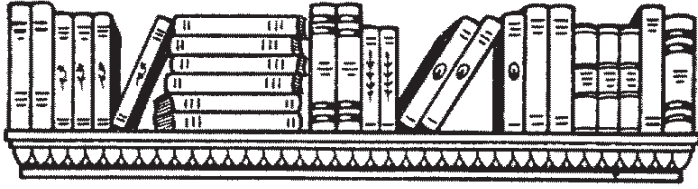

Brownlee and Ms. Greis have indicated their desire to continue to serve. Natasha Saifee, after 14 years of service to the community, has decided not to run again. We are grateful for her steadfast service to the community.

Here are the statements of those running for office this term:

BRIAN AFNAN

My wife, June, and I recently moved to the neighborhood with our three daughters. We were drawn to Section Three because of its reputation as a close-knit neighborhood and "small town feel." Our youngest, Mackenzie, has thrived at CCUMC pre-school and enjoys playdates with her friends in the afternoons. 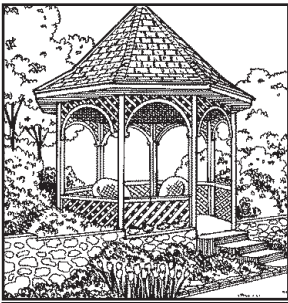
